# AWARD OF OAK LEAF CLUSTER TO SILVER STAR

MASAMI S. YOSHINARI, 01695685, First Lieutenant, Infantry, United States Army. For gallantry in action, from 6 to 16 April 1945, in Italy. Over a period of ten successive days, First Lieutenant YOSHINARI, as a forward observer, eemonstrated exceptional bravery, fortitude, and devotion to duty. He repeatedly exposed himself to all kinds of fire from hostile weapons by going in advance of the leading elements, accompanying attack platoons, and climbing the most difficult mountains to find the most advantageous positions for his OP's. First Lieutenant YOSHINARI laid down a barrage on a crossroad entering Carrara, Italy, determined the coordinates of enemy guns on Punta Bianco, Italy, from flashes, and climbed La Pizza Peak to lay fire on Fort Bastogne, Italy where at least fourteen of the enemy were killed and an unknown number wounded. Such an example of aggressive determination to take the fight to the foe exemplifies the high traditions of the Armed Forces. Entered military service from Portland, Oregon.

FRED S. KANEMURA, 01695617, Second Lieutenant, Infantry, United States Army. For gallantry in action, on 6 April 1945, in Italy. In leading his platoon in an attack, Second Lieutenant KANEMURA encountered a minefield in which two men were wounded and five men isolated. Ordering the rest of the men to a safe area. Second Lieutenant KANEMURA personally worked in the minefield alone and marked sixteen Schu mines, despite four rounds of enemy artillery which fell in the area. He then led the five isolated men a nd the two casualties to safety. Resuming his advance, he called for an artillery concentration on his objective. The foe withdrew into dugouts. Second Lieutenant KANEMURA placed two squads in covering positions and assaulted the first dugout. Firing four bullets from his carbine. he forced five Germans to surrender. Then leaving the prisoners in the care of his men, he assualted another dugut, forcing two more enemy to surrender. The men immediately cleared out five more dugouts, killing one enemy officer, wounding two, and capturing seven prisoners. Such inspiring and aggressive leadership exemplifies the gallant traditions of the United States Army. Entered service from Honolulu, Oahu, Hawaii.

KICHIO EBISUYA, 30104247, Private First Class, Infantry, United States Army. For gallantry in action, on 14 April 1945, in Italy. A platoon was subjected to intense enemy rifle and automatic weapons fire from higher ground during the initial phase of a company attack. Several attempts to close in on enemy positions by fire and movement were repulsed by atremely heavy and effective enemy fire.

concealed machine gun stopped an attempted flanking move by the support squad and pinned down the men. Private First Class EBISUYA, a rifleman from another squad, on his own initiative, began to crawl toward the machine gun nest. He crawled to within fifty yards of the foe, despite concussion grenades which were falling around him, and killed the enemy gunner with his M-l rifle and forced others to retreat. This action enabled other squads to continue their assault. Private First Class EBISUYA's courageous gallantry reflects credit on the United States Army. Entered military service from Schofield Barracks, Territory of Hawaii.

SHIRO MORIOKA, 30100996, Private First Class, Infantyy, United States Army. For gallantry in action, on 5 April 1945, in Italy. While acting as a volunteer litter bearer, Private First Class MORIOKA received an urgent call for an aid man. Noticing that all other men were busy, Private First Class MORIOKA, on his own initiative, started crawling to the aid of the wounded man. As he reached the casualty, three enemy 81mm mortar shells landed close by, one only eight yards away. When the second shell landed, Private First Class MORIOKA threw himself over the wounded man to protect him from further injury. After the third shell had landed, he secured the assistance of a rifleman in moving the casualty to a defiladed position and then to a relay post. Private First Class MORIOKA then assisted in evacuating four patients to the aid station. Each trip required five hours of travel over difficult terrain subjected to enemy sniper fire. For the next two days he evacuated men over the same difficult trail. Private First Class MORIOKA's zeal and fortitude under hazardous combat conditions reflect credit on the Armed Forces. Entered military service from Honolulu, Territory of Hawaii.

### AWARD OF SILVER STAR

JACK W. RODARME, 01297950, Captain, Infantry, United States Army. For gallantry in action, on 14 April 1945, in Italy. Captain RODARME's company was assigned the mission of taking an enemy fort which dominated the approaches to three strategic towns. Leading the company thru heavy enemy mortar fire, he continually exposed himself until his men had secured a hill overlooking the fort. He then engaged the foe for the main road leading to the fort. The company suffered heavy casualties under constant artillery and mortar barrages but finally secured the road. Captain RODARME then reorganized his platoons to assault the fort while subjected to the fire of self-propelled guns. Undaunted, he continued his advance. He and his messenger advanced 100 yards ahead of the troops and were fired on by the enemy. Engaging in a firefight, Captain RODARME emptied one clip of his carbine and when the leading platoon reached him, 17 of the foe, fully armed, had surrendered. During the entire action Captain RODARME's company killed 36 enemy and captured 56. Such courageous and aggressive leadership exemplifies the traditions of the United States Army. Entered military service from June Lake, Missouri.

# AMENDMENT OF GENERAL ORDER NUMBER 28.

So much of Section IV, General Order Number 28, this headquarters, 21 May 1945, as pertains to award of Bronze Star Medal to Private First Class Paul M. Shimada, 39013466, Infantry, is rescinded.

### AWARD OF SILVER STAR

GEORGE R. STAIRS, 01309665, First Lieutenant, Infantry, United States Army. For gallantry in action, on 5, 6, 19 and 20 April 1945, in Italy. During a battalion attack, First Lieutenant STAIRS skillfully led his platoon in taking an important hill, catching the enemy off guard. After taking the hill, the company commander ordered his platoon to hold-up and cover another platoon preparing to attack the battalion's main objective. Although his platoon was exposed to heavy concentrations of enemy mortar, machine gun and small arms fire, he deployed his men in effective support of the attacking platoon. On another occasion when his platoon was halted by 2 machine guns and small arms fire, First Lieutenant STAIRS, without regard for his own safety, personally led the platoon in overpowering the enemy position, capturing 21 and killing an unknown number. On still another occasion during an attack, First Lieutenant STAIRS, exposing himself to enemy fire, effectively deployed his platoon killing 2 snipers and causing 8 to flee. The following day he courageously led his platoon toward an enemy strongpoint. The mist, which was concealing his advance to-ward the strongpoint, lifted just as he was 75 yards within the position. Immediately the foe directed a machine pistol, machine gun, rifle grenade and mortar concentration upon First Lieutenant STAIRS, Caught in the line of this fire, he boldly stood up and inspired his men to press the attack. As the attack gained momentum, he was seriously wounded in the head by mortar fragments and fell to the ground, momentarily stunned. Realizing the enemy had superior fire power, and 17 of his men had already been wounded, he, despite his wounds, personally supervised the withdrawal of his platoon to safe positions. His bold aggressiveness, courage, and determination to close with the foe reflect great credit upon the traditional gallantry of the American Soldier. Entered military service from Mount Pleasant, Pennsylvania.

# AMENDMENT OF GENERAL ORDERS NUMBER 49, cs.

So much of Section III, General Orders Number 49, this head-quarters, 3 July 1945, as pertains to award of Oak Leaf Cluster to Bronze Star Medal to Private First Class Kiyoshi Miura, 30104574, Infantry, is rescinded.

### AWARDS OF SILVER STAR.

GEORGE G. MARTIN, Ol310360, First Lieutenant, Infantry, United States Army. For gallantry in action, on 23 April 1945, in Italy. First Lieutenant MARTIN, a platoon leader, led three of his men down the reverse side of a newly-captured slope to locate hostile emplacements. They spotted enemy positions half way down the hill and dauntlessly attacked with their rifles and hand grenades so skillfully that 7 of the well-armed foe were killed, 20 captured, and 15 routed. First Lieutenant MARTIN personally silenced two positions with accurate fire from his carbine and forced 4 enemy soldiers to surrender. He then directed such telling fire against the now-retreating foe that several more Germans were wounded and 4 machine guns, 2 automatic rifles, 9 rifles, 1 mortar, and a considerable amount of ammunition was captured. First Lieutenant MARTIN's inspiring combat leadership reflects high merit on the traditions of the United States Army. Entered military service from Burgenfield, New Jersey.

JIN ISHIKAWA, 39083586, Staff Sergeant, Infantry, United States Army. For gallantry in action, on 23 April 1945, in Italy. Staff Sergeant ISHIKAWA, a squad leader, together with his platoon leader and two other men started down the reverse side of a newly-captured hill to locate enemy positions. The group discovered a hostile position halfway down the hill and immediately opened fire while continuing to advance. Though exposed to heavy and well-directed enemy fire, the four men assaulted the foe so skillfully and courageously with guns and hand grenades that they killed seven, captured twenty, and routed fifteen of the enemy. Staff Sergeant ISHIKAWA personally killed two enemy manning a machine gun, killed another in a dugout with a hand grenade, and forced the other three occupants to surrender. He then assisted one of the other men in forcing the surrender of nine more of the enemy and capturing four machine guns, two automatic rifles, nine rifles, one mortar, and some ammunition. His heroic example of fighting spirit exemplifies the traditional gallantry of the American Soldier. Entered military service from Sacramento, California.

JACK S. SHIGETOMI, 37363564, Private First Class, Infantry, United States Army. For gallantry in action, on 23 April 1945, in Italy. Private First Class SHIGETOMI, a BAR man, together with big platoon

leader and three other men started down the reverse side of a newly-captured hill to locate enemy positions. The group discovered a hostile position halfway down the hill and immediately opened fire while continuing to advance. Though exposed to heavy and well-directed enemy fire, the four men assaulted the foe so skillfully and courage-ously with guns and hand grenades that they killed seven, captured twenty, and routed fifteen of the enemy. Private First Class SHIGETOMI personally killed one enemy with his BAR and was hit in the chest by an enemy bullet. Despite his wound, he instantly charged the hostile position and killed the foe at point blank range. He refushed to be evacuated and assisted in the complete uprooting of nine of the enemy who were throwing "potato mashers" from a dugout. His brave example of aggressiveness exemplifies the heroic traditions of the American Soldier. Entered military service from Fort Logan, Colorado.

### AWARDS OF SILVER STAR.

KATSUMI MURAI, 30102285, Technical Sergeant, Infantry, United States Army. For gallantry in action, on 18 April 1945, in Italy. Technical Sergeant MURAI's (then Staff Sergeant) platoon was given a mission of rescuing a squad in a house surrounded by the enemy. The platoon was pinned down in its approach by heavy enemy machine gun and small arms fire. Technical Sergeant MURAI crawled forward alone to within 50 yards of the house, regardless of enemy machine gun fire directed solely at him, and within 25 yards of two snipers. After tossing 3 hand grenades, he charged the snipers and killed them. Then entering the house, he reorganized the trapped squad to coordinate its fire with the approaching platoon. Under the pressure of coordinating fires, the enemy withdrew leaving his dead and seriously wounded behind. Such gallant aggressiveness exemplifies the highest traditions of the United States Army. Entered military service from Honolulu, Territory of Hawaii.

TED KUSUMOTO, 20928693, Private First Class, Infantry, United States Army. For gallantry in action, on 5 April 1945, in Italy. Crawling forward in the face of heavy enemy machine gun, grenade and rifle fire, Private First Class KUSUMOTO advanced to within fifteen yards of an enemy position when he was shaken by a grenade landing hearby. When his mind had cleared, he threw a hand grenade into the enemy position and forced the occupants to flee. Attacking another machine gun position, he crept up within throwing distance and threw two hand grenades which destroyed the machine gun and wounded the gunner. The courage and perseverance displayed by Private First Class KUSUMOTO reflects great credit on the high traditions of the United States Army. Entered military service from Whitefish, Montana.

HARRY T. SAKOHIRA, 39080210, Private First Class, Infantry, United States Army. For gallantry in action, on 23 April 1945, in Italy. Private First Class SAKOHIRA, a scout, together with his platoon leader and two other men were working as a group down the reverse side of a newly-captured slope to locate hostile strongpoints. They spotted enemy positions halfway down the hill and immediately assaulted them with hand grenades and guns so efficiently that seven of the wellarmed enemy were killed, twenty captured and fifteen routed. During this action, Private First Class SAKOHIRA aggressively silenced one position by firing his M-l from the hip and silenced an enemy machine gun nest with a hand grenade. He then forced two other enemy soldiers to surrender by pinning them down with accurate fire. Captured hostile equipment included four machine guns, two automatic rifles, nine rifles, one mortar, and a considerable amount of ammunition. 



### AWARD OF SILVER STAR

EDWARD T. DAVIS, (0528470), Second Lieutenant, Infantry, United States Army. For gallantry in action on 19, 28, and 29 October 1944, near Bruyeres and Biffontaine, France. Realizing that the enemy defending a farmhouse in a clearing were unaware of his platoon's presence, Second Lieutenant DAVIS immediately seized the opportunity and by spirited and fearless personal leadership routed the defenders after a short firefight. Later. in the drive to effect the release of an infantry battalion surrounded by the enemy, Second Lieutenant DAVIS took command of his company. At daybreak he led the company forward but was halted by intense enemy machinegun, rifle grenade and bazooka fire. Giving his men orders for the attack, Second Lieutenant DAVIS in the face of heavy fire successfully led an assault against the enemy. The Germans, demoralized by the attack, fled in confusion leaving eight of their dead. Reorganizing the company, Second Lieutenant DAVIS prepared to take "Suicide Hill", defended by one hundred enemy troops, armed with twelve machine guns, rifle grenades, and bazookas that were strategically placed to lay a screen of crossfire over the forward slope. Leading the advance of the assaulting platoons, he directed a spirited bayonet charge against the strongly fortified enemy positions. Halfway up the steep slope, with seventy-five yards to go, Second Lieutenant DAVIS was hit in the leg by an enemy machine gun bullet which knocked him to the ground. Heedless of his wound, he immediately arose and limping from place to place under enemy fire, directed his men until the success of the attack was assured. His courageous actions and inspirational leadership materially assisted in the successful relief of the trapped infantry battalion. Entered military service from Plymouth, New Hampshire.

### AWARD OF SILVER STAR

BUDDY Y. KAGAWA, (30104923), Staff Sergeant, Infantry, United States Army. For gallantry in action on 28 October 1944, near Biffontaine, France. Attacking along a heavily wooded ridge. Staff Sergeant KAGAWA proceeded ahead of his squar to clear German Flanking positions which had stopped his platoon. Grabbing an automatic rife, he sprinted from tree to tree through muderous mortar, artillery and sniper fire, killing two enemy snipers and routing two others. Then, exposing himself to direct machine gun fire, he exchanged several bursts, destroying the emplacement and killing the gunner. Having cleared the flank, Staff Sergeant KAGAWA ordered his squad forward and stood guard in an exposed position while his men prepared dug-in positions. Staff Sergeant KAGAWA was seriously wounded during an artillery barrage, but remained on guard until all his men had taken cover. The courage and fighting spirit of Staff Sergeant KAGAWA were an inspiration to his men and exemplify the finest traditions of the Armed Forces of the United S, ates.
