- 2300: Sgt in charge of the Engr squad that left earlier in the period to S-Terenzo reported that they have cleared the road from S-Terenzo to Tendola and the men are now clearing out the part of the damaged road and filling it in. Should be ready for traffic by 0500.

0012:

White 3 to White 2 - the 370th is moving from Gragnola at 0630 in the morning. Plan to move to Terrarosa. Will move along the high ground north of the road. Should be in Terrarosa by 1200. The 473rd is going north to Bodenzano from S-Stefana and expect to be there by 1400. Task Force Fukuda CP located at 816148 on the western slope of Mt Nebbione. 1 pltn on hill 657 on Mt Carbolo.

- OD17: Above msg relayed to Sgt Akita at the rear CP. To be relayed to E and G Cos.
- OlOO: Line communication to E and G Cos restored.
- Ollo: White 3 to G-6 and E-5 plans for today--G Co will send out a patrol about 0800. E Co will follow and F Co will follow E Co.

  Will advance to Ceserano and go west to objective--Aulla. The 37oth is expected to be there by 1200. Arrangements made to pick up 2 Partisans at Tendola who know that part of the country to act as guides for E and G Cos.
- 0740: White 6 and White 3 left for forward to S-Terenzo. H Co CP displaced at the same time. CP established at 0830 in S-Terenzo.
- 1030: Rear CP closed out and moving to S-Terenzo.
- 1110: Switch-board moved forward.
- 1610: CP displaced forward and arrived in the vicinity of Pallerone at 1840. Remained overnight.
- 2010: 2 TD men at the CP discussing the plans for soming operation.
- 2015: E and G Cos are about 1000 to 15000 meters east of Aulla. F Co with B Co are on Mt Castella and Mt Selta Sicco respectively. The Task Force CP at Bibola, 2000 meters south-east of Aulla.
- 2310: Liaison Officer at CP. Getting information on dispositions of troops and etc.

- 0120: S-3, 3rd Bn, 370th Infantry Regt at CP. Made contact with his Regt in regard to the situation, etc.
- 0200: Officer from E Co, 370th Infantry at CP. Informed White 6 that his Co which is about 1 kilometer east of Aulla will be pulled out at 0430 in the morning. Reported that the 370th plans are to attack to the west and cut the road at Terrarosa, 778237. The present plans of attack for the 2nd Bn is to start with E Co/and tanks and TD attached to move on highway leading to Aulla from the east. Cos G and remainder of E to attack Aulla from the high ground east and north-east of the town. The attack to begin at 0600 and will be coordinated with the attack of Task Force Fukuda coming from the south.
- 0200: Information recd that La Spezia is now occupied by elements of the 473rd Inf Regt.
- 0810: Forward CP displaced forward and established in same house with E Co, outskirts of town on northern side. The town of Aulla was cleared earlier in the day and G Co took their objective, a high hill situated on the northern part of the town.
- 1500: Bn relieved by the 3rd Bn of the 370th Inf. The Cos began to shuttle toward the rear. Bn CP displaced back to Pallerone.
- 1530: Part of Hq and H Cos began to move to the rear by motor convoy to assembly area in the vicinity of Sarzana.
- 1640: The rear CP closed out and all remaining personnel proceeded by motor convoy to Sarzana, arriving at the new assembly area at 1820. Bivouac area set up at 824067 about 2300 meters south east of Castelnuova, Italy. Usual rest area activities followed. The I and R men brought the PX rations to the CP for distribution in the morning.

### 27 APRIL 1945:

The Cos got up real early and made preparations for the coming movement. The trucks failed to show up on time. At 1100 hours the Cos finally got loaded and started to move out of the bivouac area and onto the road leading north. The roads were in the process of being repaired and therefore, the convoy was stalled for some time before we could move. After travelling most of the day the convoy closed in at new bivouac area in vicinity of Chiavari at 2330. Remained overnight.

# 28 APRIL 1945:

The Cos began to load all equipment and supplies and were ready to move out at 1030. Travelled the greater part of the day. Last of the convoy closed in at the old German Hospital in the vicinity of Busalla at 290200. Remained overnight.

## 29 APRIL 1945:

Bn began to move out at 1000 hours and arrived at Alessandria at 1300. CP established in Albergo Venezzia. Relieved the 100th Bn. Arrived in the Po Valley. Usual activities at the CP. Kitchens set up across the street from the Bn CP. All Cos in, except F Co. F Co in reserve in Busalla.

## 30 APRIL 1945:

Established road blocks and sent out motorized patrols into the adjacent towns. No enemy troops contacted. Usual activities at the CP. Meeting held at the Bn CP at 1400: --- Officers from the Brazilian Expeditionary Force at the CP getting information in regard to the dispositions of our troops and the locations of the enemy forces. They intend to send 2 Bn and a Recn group in the vicinity of Alessandria in a day or two. Asst Division Comdr at the CP. Was interested in getting any information possible about the railroad running from Turin to Genoa. Also wanted any information that we might be able to get concerning the marshalling yards in Turin that were used by the enemy. The Bn Interpreter found the men who were in charge of the rail-road and found that they could have the rail-road in working order in a couple of days. This bit of news made the Asst Div Comdr happy. Later in the evening Col Caffrey, Division Staff came over to the CP. Discussed future plans of operation. Plans made to send a party to Turin to meet the German Officers to consider surrender terms. Meeting to be made thru the British officials. Col Caffrey plans to head the party and leave at Domos nod orrowns wht
